A Treatment Planning Workshop for Hygienists: Coaching Periodontal Patients in Oral Rehabilitation

Dental hygienists play an important role on dental teams in building relationships with patients. Those relationships establish trust and provide opportunity to educate, encourage and motivate the behavior change necessary to achieve oral systemic health and smile rehabilitation. To best educate and inform, it is important for hygienists to have knowledge of medical history, periodontal treatment, periodontal recall, restorative options for occlusal rehabilitation, and informed consent for tooth replacement. Dr Nygaard will introduce a challenging case for participating hygienists to consider possible treatment options. They will be able to think about ways to restore periodontal health, enhance chewing function and the patient's smile, and develop an ideal plan to increase longevity. Dr Nygaard will share the completed treatment and the impact of this case as an example of the life changing dentistry dental teams create every day!

Upon completion of this session, attendees should be able to:

- Identify clinic parameters that dictate non-surgical vs surgical periodontal therapy.
- Effectively inform patients about tooth replacement options for missing teeth.
- Identify ways to keep patients motivated to continue in recall for the long haul to achieve oral systemic health and reconstructive success.



Anesthesia and Pain Management, AGD Subject Code 340

The challenge faced by all clinicians today is to provide safe and effective dental treatment and achieve positive outcomes while avoiding medical complications. It is imperative all dental practitioners are equally aware of the medical considerations of agents commonly used in the practice of dentistry. This program will present a dental pharmacology update for the whole team. Special emphasis will be given to those medications prescribed or administered in the practice of dentistry whose actions, effects or interactions with other drugs may impact the treatment of systemic disease.

Upon completion of this session, attendees should be able to:

- Describe the pharmacology of opioid and non-opioid analysesics used in the management of acute dental pain, including best practices for prescribing and proper storage and disposal of unused dosages.
- Describe techniques useful in identifying potential opioid addiction and current protocols for its treatment.
- Discuss local anesthetic agents with respect to their mechanism of action, adverse effects and contraindications.
- Explain the rationale for the use of vasoconstrictors and potential adverse effects.
- Examine the pharmacology of anti-infective agents commonly used in dentistry and their clinical considerations.
- Describe the pharmacology, mechanism of action, routes of administration, adverse effects and dental considerations of cannabis.

The Essence of Oral Pathology: A Review of Oral Cancer and Oral Pre-Malignancy

Lecture up to 2.5 hours

Early detection and diagnosis of oropharyngeal squamous cell carcinoma continue to be the most significant factors affecting the survival rate. This course will: discuss the clinical appearance of squamous cell carcinoma and of pre-malignant lesions (epithelial dysplasia); describe how to perform an effective oral cancer screening examination; describe known risk factors for squamous cell carcinoma including human papilloma virus; discuss how to harvest and submit biopsy specimens that will be of highest diagnostic value; explain the components of a pathology report including the microscopic features that result in a cancer (or precancer) diagnosis; and address current staging and management of head and neck squamous cell carcinoma.

Upon completion of this session, attendees should be able to:

- Perform an effective oral cancer screening examination.
- Identify soft tissue abnormalities that are suspicious for squamous cell carcinoma or epithelial dysplasia.
- Understand the significance of various risk factors for squamous cell carcinoma.
- Recognize how the quality of a biopsy specimen and information provided to the pathologist affects the accuracy of a microscopic diagnosis.
- Interpret a biopsy report and understand the microscopic features of squamous cell carcinoma and epithelial dysplasia.



Dr Dave Chandra is the director of oral pathology biopsy services at Oregon Health and Sciences University. He is board certified in oral and maxillofacial pathology. He teaches several pathology courses at OHSU School of Dentistry to dental students and residents. He received both his DMD and PhD degrees from the University of Pittsburgh (Pennsylvania) and completed his oral pathology residency training at Long Island Jewish Medical Center (New York).

Photography is an indispensable tool to optimize lab communication, assist with case presentation, and market your dental services. 
